

DanceSport competitions are an official event approved in the unified calendar of sports events of Ukraine for the period from 01.01.2021 to 31.12.2021.



Competitions are held in accordance with the AUDSF and WDSF rules.

Judges:

Open categories are judged by adjudicators with a valid AUDSF or WDSF license only. Participation in the classification competition as a judge is possible only in accordance with a valid judge license. Refereeing in classification competitions is carried out by judges of the relevant categories subject to the submitted online application for refereeing. The application deadline is 23:59 May 27, 2021.

Application for participation:

All athletes / dance couples must submit an online application for participation in the competition on the official website <https://audsf.org/competition/2021> by 23:59 May 27, 2021.

Important information! Conditions for preventing the spread of COVID- 19:

The event is held without the permission of spectators.

Team leaders (coaches) submit in advance the application of the established sample for the participation of accompanying persons* in competitions (entrance to competitions) to e-mail dsc.foxtrot@gmail.com (+copy skdynamo@mail.lviv.ua) by 23:59 May 27, 2021.

* Official accompanying persons - persons who are an integral part of club teams without whom it's impossible for athletes to participate in competitions (for example, parents of minor athletes, coaches, etc.)

The number of accompanying persons is limited. The organizer has rights to limit the number of accompanying persons for one team/club.

STRICTLY! Registration of participants (athletes, coaches, accompanying persons) is carried out by one person from the club (team leader) only, once by one package for all competitions (categories) according to the previous application. The coach (representative) of the club receives the entire package for the whole club (numbers, incoming, etc.) for all categories (preliminary, before 21:00 May 28, 2021 agreeing all details with the registration commission - Tetyana Kozak +380637572997; +380679772119; skdynamo@mail.lviv.ua) Changes to registration, or to accompanying person list on the day of the competition is impossible!

Registration is completed strictly 20 minutes before the start of each competition.

The competition will be held without warm-up.

Participants perform strictly according to the previously provided schedule. The stay of participants in the sports complex "Gratsiya" is possible only during the preparation for the performance, not earlier than 60 minutes before the performance and, in fact, the time of the competition (the part in which the athlete is participating). Staying indoors all day, waiting for other participants is impossible. Team leaders are asked to take care of this.

Preliminary registration for participants (athletes and accompanying persons) from L'viv is mandatory and will take place on May 28, the place will be announced additionally.

All persons must wear a protective medical mask throughout their stay at the venue. Exceptions are athletes who compete directly on the dance floor.

Persons who do not respect the precautionary measures and requirements may be denied participation in the event and stay indoors. Such persons may also be held administratively liable.

Financial conditions

in the categories for participation in competitions is:

"School", "Debut", "N" – 300 UAH from the participant for the program;

"E", "D", "C+B" – 400 UAH from the participant for the program;

Open categories – 500 UAH from the participant for the program.

Contributions from accompanying persons are 200 UAH per person on the day of the competitions.

Seats at the tables are paid an additional 400 UAH/table (4 seats) for each part of the competitions.
